In the event of "dust off" or "walk off" of a SUPERFLOOR" treated floor within the warranty period, Husqvarna shall supply and ship to the location of the SUPERFLOOR" treated floor the necessary chemicals and diamond too's for the restoration of the SUPERFLOOR" treated floor to the condition of the floor immediately after first application of the SUPERFLOOR" system.


